Competitors will be excluded from the results for the following offences.

- 1 Failure to wear safety belt and crash helmet of the approved type while on the course.
- 2 Failure to have appropriate type fire extinguisher in the car at all times during the event
- 3 Failure to pass scrutiny or to arrive at scrutiny after practice has begun.
- 4 Failure to obey a reasonable request from an official.
- 5 Use of spikes, studs, chains and altered tyre patterns.

Scrutiny Requirements.

All cars must pass scrutiny

All cars must be fitted with fire extinguishers of approved type

All cars must be fitted with full roll cage and have laminated windscreens.

All cars must be fitted with FIA approved seats.

Fire proof clothing must be worn as per MI regulations.

Overhead/ roof skid pans and side netting are compulsory on specials.

Seats, safety belts and helmets of approved type must be used. See specification in current yearbook and latest MI bulletins.

Classes

Class 1	Sports Cars & Saloons cars up to 1400cc with engine over driven wheels.
Class 2(a)	Saloon & Sports Cars from 1401cc to 1650cc with engine over driven wheels.
Class 2(b)	All other Saloon & Sports Cars to 1650cc.
Class 3(a)	Saloon & Sports Cars over 1650cc with engine over driven wheels.
Class 3(b)	All other Saloon & Sports Cars not qualifying for Class 1, 2 or 3(a).
Class 4(a)	Specials, Single Seaters Sports Racing Cars all Motorcycle engined cars including 4WD cars up to 2100cc. Open only to Competitors 18 years and over.
Class 4(b)	Specials, Single Seaters & Sports Racing Cars including 4WD Cars over 2100cc. Motorcycle engines not allowed. Open only to Competitors 18 years and over.
Class 5(a)	"Intermediate class" for 16 – 18 year olds, holding a "Speed National B" license in saloon cars up to 1650cc.
Class 5(b)	"Junior Class" for 14 – 16 year olds, holding a "Junior" license in saloon cars up to 1400cc.
Class 6	Optional Class for Club Members cars, unlimited cc. This class is not eligible for championship awards and points.

AWARDS

FTD Specials and FTD Saloons 1ST, 2ND & 3RD in each class, GMC Driver, Ladies Award and Best Newcomer.

Winners of the overall award will not be eligible for class awards. Additional awards may be presented.

Protests will only be accepted as per MI regulations. No case for force majeure will be considered once a competitor has started the event.

Ties except for FTD will be resolved in favour of the competitor with the smallest cc's. Failing this, the fastest first run.

THE CLERK OF THE COURSE HAS THE RIGHT TO REFUSE AN ENTRY without having to assign a reason.
