#### ONE EVENT LICENCES WILL BE AVAILABLE AT THE START FOR THOSE WHO ARE NOT HOLDERS OF A FULL ANNUAL COMPETITION LICENCE

<u>PENALTIES</u>: The time taken for each test will be the penalty for that test, with additional penalties as follows: each initial contact with a pylon: 5 seconds, each line fault: 5 seconds. The maximum loss (including failure) on any test will be the best correct performance in class plus 20 seconds.

NOTE THAT ALL LINES DURING A TEST MUST BE CROSSED BY A CAR'S LEADING WHEELS ONLY - i.e., STOP ASTRIDE ALL LINES. THERE IS A 5 SECOND PENALTY FOR PUTTING THREE OR FOUR WHEELS (or only ONE) ACROSS A LINE.

More than one driver will be allowed per car. Ties will be decided by the better time on test 1. The organisers will be the sole judges of eligibility for each class.
