2017 ENDURANCE TRIAL

The Event is an open Endurance Trial, promoted and organised by Tipperary Light Car & Motorcycle Club Limited, hereinafter called the promoters. It will be held under the International Sporting Code of the FIA, the General Competition Rules of Motorsport Ireland (MI), Appendix 35 MI Yearbook 2017, these supplementary regulations and any final instructions issued before the start of the event.

The entry list opens on receipt of these regulations and will close on Tuesday 23rd May 2017

The entry fee is as follows: € 200 which includes € 25 standard rate IRDS/BRDS insurance premium,€30

(per crew) competitors personal accident insurance & an increase in Public Liability Premium (€50 total

per event)

Total Entry amount Due: € 200 (Less a deduction of €7 per person for those aged 16 / 17)

Entry Forms must be fully completed and accompanied by a cheque (**not post-dated**) for **€200** made payable to **Tipperary Motor Club Ltd.** All cheques will be lodged on receipt. All entries must be made on the official entry form and accompanied by the appropriate fee and sent to: **Ann Heney, Camas, Cashel, Co. Tipperary**

The maximum entry for the event is 70.

Should any of the above be not reached, the organizers have the right to cancel the event or amalgamate classes as necessary. **Turbo and four-wheel drive vehicles are ineligible.** Cars will start at 1 (one) minute intervals, except where directed otherwise by the organisers (some selectives will be at 30 second intervals)

CLASSES

The entry will be divided into six classes, as follows:

- a1) Cars built to Endurance specification up to 1000cc
- a2) Cars built to Endurance specification from 1001 to 1400cc
- **b)** Navigation Trial cars up to 1400cc
- c) Navigation Trial cars from 1401 to 2000cc
- d) Front Wheel Drive Retro type cars (retro cars as defined in appendix 33)
- e) Rear Wheel Drive Retro type cars (retro cars as defined in appendix 33)

Note re tyres:

Note re tyres for Endurance Trials: Further to Article 21.14 of Appendix 35, the sub-committee has decided that the following will apply in regard to Tyres on Endurance Events for 2017:

A: The general overall prohibition on tyres with marking such as "for Competition Use only" will continue.

B: Retro Classes: Tyres Free (subject to "A" above). (It is noted that such cars are not eligible for overall awards, that numbers are limited, and that available wheel sizes for Retro Cars impose limitations on the availability of suitable tyres).

C: All other Classes: Tyres Free (subject to "A" above) except that Yokohama A021R tyres are prohibited on driven wheels.

AWARDS: 1st, 2nd & 3rd Overall 2 Trophies

1st, 2nd & 3rd Class 2 Trophies

The Overall winner will be decided from Class A1/A2 only

Indemnification:

Furthermore, in respect of any parts of this event on ground where Third Party Insurance is not required by law, this Agreement shall in addition to the parties named above extend to all and any other competitor(s) and their servants and agents and to all actions, claims, costs, expenses and demands in respect of loss of or damage to the person or property of myself, my driver(s), passenger(s) or my taking part is a servant agent. (if applicable, state "over 18 years").

(b) I declare that to the best of my belief the driver(s), passenger(s) possess the standard of competence necessary for an event of the type to which this entry relates and that the car entered is suitable and roadworthy for the event having regard to the course and the speeds which will be reached.
I declare that the use of the car hereby entered is covered by Insurance as required by the Road Traffic Act, which is valid for such part of this event as shall take place on roads as defined in the Act.

(c) I understand that should I at the time of this event be suffering from any disability whether permanent, temporary or otherwise which is likely to affect prejudicially my normal control of my automobile, I may not take

Furthermore, the parents and/or guardians of persons under 18 years of age shall grant permission to MI and the Irish Sports Council to carry out tests in accordance with the Irish Anti-Doping Rules (Rule No 139) in the following form:

"I/We hereby grant permission to MI and the Irish Sports Council to carry out tests as set out in Rule No 139 of the GCRs in accordance with the Irish Anti-Doping Rules."
