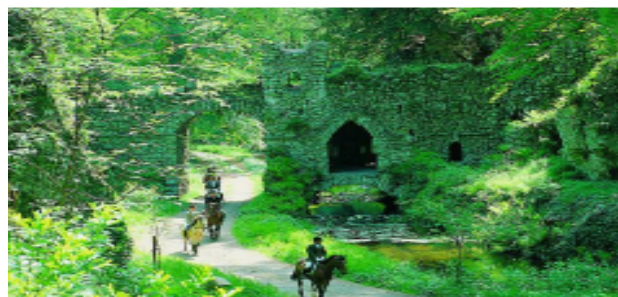

1. The Event is an open Endurance Trial, promoted and organised by ALMC Motor Club Limited, hereinafter called the promoters. It will be held under the International Sporting Code of the FIA, the General Competition Rules of Motorsport Ireland (MI), Appendix 35 MI Yearbook 2018, these supplementary regulations and any final instructions issued before the start of the event.

2. **The entry list opens on receipt of these regulations and will close on Wednesday 21<sup>st</sup> February 2018**

**The entry fee is as follows: € 199**

**Which includes € 25 standard rate Driver IRDS/BRDS and € 30 (per crew) CPA insurance**

**Total Entry amount Due: € 199 (Less a deduction of €7 per person for those aged 16 / 17)**

Entry Forms must be fully completed and accompanied by a cheque (**not post-dated**) for **€199** made payable to **ALMC Motor Club Ltd.** All Cheques will be lodged on receipt.

**3. The maximum entry for the event is 60.**

Should any of the above be not reached, the organizers have the right to cancel the event or amalgamate classes as necessary. **Turbo and four-wheel drive vehicles are ineligible.**

4. Cars will start at 1 (one) minute intervals, except where directed otherwise by the organisers (some selectives will be at 30 second intervals)

### **5. Classes**

The event will have seven classes as follows:

Class 1A: Cars built to Endurance Specification up to 1000cc

Class 1B: Cars built to Endurance Specification between 1001cc and 1400cc

Class 2: Navigation Trial cars up to 1400 c.c.

Class 3: Navigation Trial cars from 1401 to 2000 c.c.

Class 4: Front Wheel Drive Retro type cars.

Class 5: Rear Wheel Drive Retro type cars.

Class 6: All Sports Cars \*

\* All MX5 roofs must be of a steel form, either bolted or stitch welded to the bodywork.

## **Tyres for Endurance Events:**

- There is a general prohibition of tyres marked "for competition use only" or "for rally use only" would be continued. Cars using tyres that in the opinion of the Organisers/Scrutineers have an "Aggressive Pattern" may be refused a start unless rectified.

## **6. Awards**

- **General Classification:** 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> Overall - 2 Awards plus Perpetual Cups
- **Class Awards:** 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> in each Class - 2 Trophies. (Subject to Entries)
- **Novice Driver Award :** Driver has previously competed on less than 3 Endurance / Lanes events.
- **Novice Navigator Award:** Navigator has previously competed on less than 3 Endurance / Lanes events
- **Beginners Award :** Crew must have never previously competed on Endurance / Lanes events.
- **Gary Emmet Trophy:** Awarded for the best prepared crew ( not necessarily a car) at the discretion of the organizers

**The Overall winner will be decided from Class 1A or IB (Endurance Class) only.**

Amalgamation of Classes or Additional awards may be announced at signing-on before the Event.

## **ELIGIBILITY FOR AWARDS:**

Those receiving awards for overall placing will not be eligible for class awards except for Class 1B unless they have finished in the top three overall.

## **7. General Route.**

Organisers will use 1:50,000 maps when they are setting out the route card, but it is not envisaged that competitors will need maps, as a route book will be provided.

In consideration of the acceptance of this entry or of my being permitted to take part in this event I agree to save harmless and keep indemnified the ALMC Motor Club Limited (Organising Club), Irish Automobile Club Ltd. t/a Royal Irish Automobile Club, Irish Motorsport Federation Ltd. t/a Motorsport Ireland and their respective officials, servants, representatives and agents from and against all actions, claims, costs, expenses and demands in respect of death, injury, loss of or damage to the person or property of myself, my driver(s), passenger(s) or mechanic(s) (as the case may be) howsoever caused arising out of or in connection with this entry or my taking part in this event and notwithstanding that the same may have been contributed to or occasioned by the negligence of the said bodies, their officials, servants, representatives or agents.
