This is the final round of the D&B Windows Motorsport Ireland's National Autocross Championship 2013 & a counting round of the Munster Autocross Championship.

Regulations

This will be an open Grass Surface Autocross to be held under the international sporting code of the FIA, the GCR'S of Motorsport Ireland including appendix 85.1, 85.2 & 87 of the 2013 Motorsport Ireland yearbook, these supplementary regulation and any other final instructions that may be issued. Motorsport Ireland Permit No. 13/??? has been issued for the event. The organizers have reserved the right to cancel or postpone the event or part of it in exceptional circumstances.

Venue - Garryvoe, Castlemartyr, Co. Cork.

The event takes place on private property at Garryvoe, Castlemartyr. Exit the N25 main Waterford – Cork rd at Castlemartyr, direction Ballycotton. The event will be arrowed from Castlemartyr..

Timetable: *Scrutiny* 10.00hrs – *Practice* 11.30hrs – *Start* 12.00hrs

Competitors: Entries are open to all drivers whom hold a current license and log book, which must be produced at scrutiny. Since no part of the event takes place on public roads, cars need not comply with the requirements of the road traffic act, provided that such cars are not driven to the event. A maximum of 3 drivers per car will be allowed.

Classes: Class 1 Saloons & Sports Cars up to 1400cc with engine over driven wheels.

Class 2(a) Saloons & Sports Cars from 1401cc to 1650cc with engine over driven wheels.

Class 2(b) All other Saloons & Sports Cars to 1650cc.

Class 3(a) Saloons & Sports Cars over 1650cc with engine over driven wheels. Class 3(b) All other Saloons & Sports Cars not qualifying for Class 1,2 or 3(a).

Class 4(a) Specials, Single Seaters Sports Racing Cars all motorcycle engined cars including 4 WD cars up to 2100cc.

Only open to competitors 18 years and over.

Class 4(b) Specials, Single Seaters & Sports Racing Cars including 4WD Cars over 2100cc. Motorcycle engines not

allowed. Only open to competitors 18 years and over.

Class 5(a) "Intermediate class" for 16 – 18 year olds, holding a "Speed National B" license in saloon cars up to 1650cc.

Class 5(b) "Junior class" for 14 – 16 year olds, holding a "Junior" license in saloon cars up to 1400cc.

Scrutiny Requirements: All vehicles must pass scrutiny

All vehicles must be fitted with fire extinguishers of approved type

All vehicles must be fitted with a full roll cage All saloon cars must have laminated windscreens. All vehicles must be fitted with FIA approved seats. Fireproof clothing must be worn as per MI regulations.

Overhead/roof skidpans and side netting are compulsory on specials.

Seats, safety belts and helmets of approved type must be used. See specification in current yearbook and

latest MI bulletins.

Timing: Timing will be to $1/100^{th}$ of a second from a flying start to a flying finish.

Awards: Awards will be presented to FTD Saloon and Special, 1st, 2nd & 3rd in each class and to 1st, 2nd & 3rd Lady.

Winners of the overall awards will not be eligible for class awards. Other awards at the clubs discretion.

Exclusion: Competitors <u>will</u> be excluded from the results for the following offences.

Failure to wear safety belt and crash helmet of the approved type while on the course. Failure to have appropriate type fire extinguisher in the car at all times during the event

Failure to pass scrutiny or to arrive at scrutiny after practice has begun.

Failure to obey a reasonable request from an official. Use of spikes, studs, chains and altered tyre patterns.

Protests: Protest will only be accepted as per MI regulations.

Entry Fee: €90. Juniors & Intermediates €45. (all include Competitors Personal Accident Insurance).
