Competitors MUST wear fireproof three layer suits, fireproof balaclava, gloves, socks and boots as specified in MI YEARBOOK and bulletins.

#### Practice

All competitors MUST walk the hill before the commencement of practice. One timed practice run will be given and, in addition, one untimed practice run may also be given. All Double Drivers MUST display the letter 'D' on the car.

The onus will be on the competitor to clear all litter, oil spillages etc.
