- The entry fee is €195 which includes IRDS/BRDS insurance premium at the standard rate and €30 (per crew) competitors personal accident insurance (less a deduction of €7 per person for those aged 16/17). The entry fee also includes lunch at the hotel.
- Entry forms must be fully completed and accompanied by a cheque dated not later than 12<sup>th</sup> August. Cheques should be made payable to County Monaghan Motor Club.

- Cars will start at one minute intervals, except where directed otherwise by the organisers.

#### **CLASSES**

The entry will be divided into six classes, as follows:

- a1) Cars built to Endurance specification up to 1000cc
- a2) Cars built to Endurance specification from 1001 to 1400cc
- b) Navigation Trial cars up to 1400cc
- c) Navigation Trial cars from 1401 to 2000cc
- d) Front Wheel Drive Retro type cars (retro cars as defined in appendix 33)
- e) Rear Wheel Drive Retro type cars (retro cars as defined in appendix 33)

Further to the provisions of Art 21.14 of Appendix 35, the Navigation Sub-committee have decided the following:

For 2015, tyres will be free, with the exception that Yokohama A021R tyres are prohibited on driven wheels, and that the general prohibition of tyres marked "for competition use only" or "for rally use only" would be continued.
