Final Instructions 1

Thank you for entering the Crafted Fitted Furniture Jim Walsh Cork Forest Rally 2016. We are delighted to be back in Mallow where all the services are conveniently located. This year we have prepared 3 stages for you, all run twice and we hope you find the carefully chosen smooth forest tracks to your liking. We're looking forward to seeing your reaction to the Duhallow stage SS 3+6, all 15.3KM of it.

We would ask you to familiarise yourselves with the following details so that we can have the safe and efficient rally that the event is best known for.

- 1. Competitors are reminded that IRDS does NOT start until Parc Ferme out on Sunday Morning August 14th.**
- 2. Mechanical scrutiny takes place on Saturday August 13th in EARS workshop, Quartertown Industrial Estate, Mallow, *GPS Coordinates N 52°07.524' W 008°40.081'* which will open at 17.30 and close at 21.30 sharp. Please be on time.**
(EARS Motorsport have very kindly facilitated the club by allowing us the use of their premises during opening hours. Please note that Saturday August 13th is a working day in the scrutiny area so do obey the instructions from the marshals and do not obstruct any gates or doors in the mechanical scrutiny area)
- 3. Documentation scrutiny takes place on Saturday August 13th in the Cork County Council Offices, Annabella, Mallow. *GPS Coordinates N 52°08.407' W 008°39.235'* Documentation scrutiny will open at 17.30 and close at 22.00 sharp. Please be on time.**
- 4. The official notice board will be located at documentation scrutiny on Saturday August 13th until close of documentation scrutiny. The official notice board will be located at the event HQ, The Roundabout Inn for the remainder of the event.**
- 5. Parc Ferme is located at the Cork County Council Offices, Annabella. Mallow. *GPS Coordinates N 52°08.407' W 008°39.235'* Parc Ferme closes at 22.15 Saturday 13th sharp.**

No exceptions.

6. Service Barges will be given entrance to the service area on Sunday August 14th, but only if their service pass is affixed to the windscreen of the vehicle.

NO EXCEPTIONS.

Note that ground sheets are compulsory and must be used.

7. The trailer park for the event is located behind the Cork County Fire Station, Annabella, Mallow. **GPS Coordinates N 52°08.543' W 008°39.246'** This may only be accessed from the Limerick Rd Roundabout on the N20. The access point will be sign posted for traffic coming from both the Cork and Limerick directions. The trailer park will open at 16.30.

All cars must be unloaded in the trailer park prior to entering Parc Ferme.

No exceptions.

Road through trailer park **MUST be kept clear to allow access by Fire Service Personnel.**

8. All tyre trucks, fuel suppliers etc will be located in the service area at Quartertown Industrial Estate on Saturday August 13th and Sunday August 14th. A one way system will be in operation.
9. Competitors safety briefing will be held in the Cork County Fire Station which is 400meters from Rally H/Q, the Roundabout Inn and adjacent to Parc Ferme, on Sunday August 14th at 08.30. *Please be on time.*
It is mandatory that ALL crews attend and penalties as per APP 25 art 3.2 for non attendance will apply. A random check may be carried out.
10. Parking will not be permitted on the road or in the vicinity of Parc Ferme on Sunday August 14th at any time.
11. This event will use CMC's new Live Timing System which allows competitors to access their stage times and results on line at www.harcon.ie. Results will also be distributed at service in control.
12. All reseeding **MUST** be completed by 21.00 so as to allow publication of the start list
13. Please note the following changes. Greg McCarthy replaces Paul Casey as Dep COC. Paul is now Club Safety and Asst COC. Noel Ferriter is Club Steward & Emergency Services Coordinator (ESLO).
