Licence Requirements: All drivers must hold a valid competition licence, which must be available for inspection at the start. ONE EVENT LICENCES WILL BE AVAILABLE AT THE START FOR THOSE WHO ARE NOT HOLDERS OF A FULL ANNUAL COMPETITION LICENCE

Penalties: The time taken for each test will be the penalty for that test, with additional penalties as follows: each initial contact with a pylon: 5 seconds, each line fault: 5 seconds. The maximum loss (including failure) on any test will be the best correct performance in class plus 20 seconds. **NOTE THAT ALL LINES DURING A TEST MUST BE CROSSED BY A CAR'S LEADING WHEELS ONLY - i.e., STOP ASTRIDE ALL**

LINES. THERE IS A 5 SECOND PENALTY FOR PUTTING THREE OR FOUR WHEELS ACROSS A LINE

Classes:

A All Mini saloons

B Front wheel drive Specials

C Rear wheel drive Sports Cars & Specials

D All saloons, other than Minis

E Road going cars, including Multi-Venue cars

F Beginner Autotest Challenge (Non Championship)

More than one driver will be allowed per car. Ties will be decided by the better time on the first test. The organisers will be the sole judges of eligibility for each class.

Awards: Overall Winner. 1st, 2nd, 3rd in each of classes A-E, provided there are sufficient entries. 1st

Novice in each of classes A-D. Best Semi-Expert Overall. 1st in Class F. No competitor may win more than one award. The organisers reserve the right to amalgamate classes if necessary. Further awards may be given at the organisers' discretion.
