START: Fairyhouse Racecourse, Fairyhouse, Co Meath 11:00am SHARP

Check-in from 8:45 am until 10:15 am. Competitor Safety Briefing: 10:30 am.

LICENCES: All drivers must hold a valid 2019 competition licence, which must be available for inspection / purchase at the start.

ONE EVENT LICENCES WILL BE AVAILABLE FOR THIS EVENT

PENALTIES:

Failure to start at the correct time or when notified by the marshals (unless previously agreed with the CoC) will result in a 5 second penalty per minute late being applied.

The time taken for each test will be the penalty for that test, with additional penalties as follows:

- each initial contact with a pylon: 5 seconds,
- each line fault: 5 seconds.
- failure to stop in a stop box: 5 seconds,
- failure to ATTEMPT TO STOP in a stop box: 20 seconds
- The maximum loss (including failure) on any test will be the best correct performance (overall) plus 30 seconds.

NOTE THAT ALL LINES DURING A TEST MUST BE CROSSED BY A CAR'S LEADING WHEELS ONLY - i.e., STOP ASTRIDE ALL LINES. THERE IS A 5 SECOND PENALTY FOR PUTTING THREE OR FOUR WHEELS (or only ONE) ACROSS A LINE.

AWARDS: Overall winner: Fairyhouse Cup

Awards will be presented in each class at the discretion of the organisers.

These will be presented shortly after the finish

INSURANCE: AS THE ENTIRE EVENT TAKES PLACE ON PRIVATE PROPERTY, IRDS INSURANCE COVER IS NOT REQUIRED.

PASSENGERS:

All passengers must sign the indemnity wording on the entry form for that car. In the case of passengers aged 16 or 17 years, this must be countersigned by a parent or guardian.

Passengers are not required to hold competition licences. All passengers must pay a Competitors' Personal Accident insurance premium of €5 (aged 18 years or over) or €3 (aged 16 or 17 years).

NOTE – DO NOT INCLUDE CPA PASSENGER INSURANCE WITH PAYPAL PAYMENTS. THEY MAY BE PAID AT CHECK-IN.

CARS: Only normal production, 2 wheel drive, non-turbo cars will be allowed.

ALL CARS MUST BE PROPERLY SILENCED. ANY CAR SUFFERING EXHAUST DAMAGE WILL NOT BE ALLOWED TO CONTINUE.

TYRES: NO "KNOBBLY" TYPE TYRES ALLOWED ON THE DRIVEN WHEELS ,that will damage the racecourse surface

CLASSES:

- 1. Front wheel drive up to 1000 cc,
- 2. Front wheel drive over 1001 and under 1400 cc,
- 3. Front wheel drive cars over 1401cc.
- 4. Sports Cars,
- 5. Other Rear wheel drive,

This is primarily a fun event. Ties will be decided by the better time on test 1, and so on.

Two drivers will be allowed per car. Where two drivers are sharing a car, both names must be shown on entry form to assist in deciding running order.

THE ORGANISERS WILL BE THE SOLE JUDGES OF CLASS ELIGIBILITY. Ties will be decided by the better time on Test 1, and so on. .
